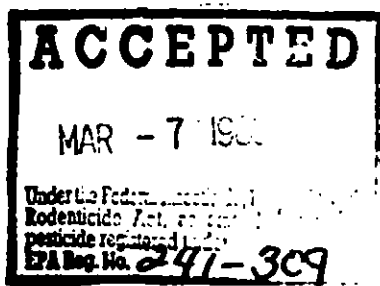

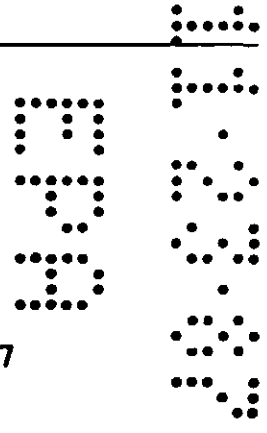
STATEMENT OF PRACTICAL TREATMENT
