


DIRECTIONS FOR USE

GENERAL INFORMATION

For optimal weed control management, apply a soil applied grass herbicide such as PROWL[®], TRI-4[®], or Treflan² followed by PURSUIT postemergence. If common lambsquarters are not adequately controlled by the soil applied treatment, Pinnacle herbicide may be tank-mixed with PURSUIT for additional activity.

The addition of Pinnacle to PURSUIT may cause severe injury and/or stunting to soybeans, especially when applied under hot, humid conditions. The USER ASSUMES ALL RISKS AND CONSEQUENCES associated with applications of this tank-mixture to soybeans.

APPLICATION RATES

When tank-mixing Pinnacle with PURSUIT, use the following rates:

PURSUIT - 4 ounces per acre

Pinnacle - 0.125 ounce per acre

Add to the spray mixture:

Non-ionic surfactant - 1 quart per 100 gallons (0.25% v/v)

AND

Liquid nitrogen based fertilizer (such as 28%N, 32%N, or 10-34-0) at the rate of 1-2 quarts per acre. Instead of a liquid fertilizer, spray grade ammonium sulfate may be used at the rate of 2.5 lbs./A.

WEEDS CONTROLLED

This tank-mixture will improve the activity of PURSUIT on common lambsquarters. Refer to the PURSUIT label for additional weeds controlled.


RESTRICTIONS

Apply to 1-3 trifoliolate stage soybeans only.
