


#### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. This labeling must be in the possession of the user at the time of herbicide application. The use of SCEPTER O.T. herbicide not consistent with this labeling may result in injury to crops. Keep container closed to avoid spills and contamination. **DO NOT** apply this product through any type of irrigation system.

#### **GENERAL INFORMATION**

SCEPTER O.T. provides control of broadleaf and grass weeds when applied postemergence. SCEPTER O.T. can be applied to either conventional or no-till soybeans. Roundup or glyphosate containing products may be tank-mixed with SCEPTER O.T. for enhanced control of weeds common to soybean production. When applied postemergence, tank mixes containing Roundup herbicide or glyphosate containing products can only be applied to Roundup Ready soybeans. Refer to the SCEPTER O.T. label and the Roundup or glyphosate containing product label for specific use recommendations, rates and weeds controlled.

#### **MIXING INSTRUCTIONS**

Fill the spray tank one-fourth to one-half full with clean water. When tank-mixing SCEPTER O.T. with Roundup or glyphosate containing products, while agitating, add the required amount of SCEPTER O.T. to the spray tank first and make sure it is thoroughly mixed before adding the other herbicide; then fill the remainder of the tank with clean water. Maintain agitation while spraying to ensure a uniform spray mixture. For postemergence applications, add the nonionic surfactant as the last ingredient in the tank. To avoid injury to sensitive crops, spray equipment used for SCEPTER O.T. herbicide applications must be drained and thoroughly cleaned with water before being used to apply other products.
