### DIRECTIONS FOR THE USE OF LIGHTNING HERBICIDE IN COMBINATION WITH OTHER POSTEMERGENCE HERBICIDES FOR WEED CONTROL IN IMI-CORN

Apply LIGHTNING herbicide only on selected field corn hybrids (IMI-CORN) warranted by the seed company to possess resistance/tolerance to direct application of LIGHTNING.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

This labeling must be in the possession of the user at the time of pesticide application.

Observe all cautions and limitations on this label and on the labels of products used in combination with LIGHTNING. Do not use LIGHTNING other than in accordance with the instructions set forth on this label. The use of LIGHTNING not consistent with this label may result in injury to crops.

DO NOT apply this product through any type of irrigation system.

Use of crop oil concentrates or methylated seed oils as adjuvants in LIGHTNING herbicide combinations with Marksman herbicide may result in crop injury if applied during periods of cool, wet weather or hot and/or humid weather. Under these environmental conditions the use of a nonionic surfactant is recommended.

Do not use crop oil concentrate or methylated seed oils when Buctril+atrazine is used in a tankmix with LIGHTNING.

When LIGHTNING is used in combination with another herbicide, refer to the respective label for rates, methods of application, proper timing, weeds controlled, restrictions, and precautions. Always use in accordance with the more restrictive label restrictions and precautions.
