- 1. In the Ingredients statement, insert the common name "Imazamox" prior to the chemical name, and place the chemical name in parentheses.
- 2. In the DIRECTIONS FOR USE section, change "Consult BASF.." to "It is recommended that the user consult BASF.."
- 3. In the DISCLAIMER section, add "To the extent permitted by law," immediately prior to "any damages arising..."
- 4. Submit one copy of your final labeling before you release your product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release of product for shipment constitutes acceptance of these conditions.

This labeling supercedes all previously accepted labeling for this product (except supplemental labeling). A stamped copy of the label is enclosed for your records.
