PURSUIT W DG HERBICIDE USE AREA

PURSUIT W DG may be used on succulent peas, dry edible peas (including chickpeas), lentils, and lima beans in Washington (Adams, Asotin, Columbia, Garfield, Lincoln, Spokane, Walla Walla and Whitman counties), Idaho (Benewah, Clearwater, Idaho, Kootenai, Latah, Lewis, and Nez Perce counties), Oregon (Gilliam, Morrow, Union, Umatilla and Wallowa counties) and Montana only.

USE RATE

Apply PURSUIT W DG herbicide at a broadcast rate of 1.1 ounces per acre for preplant, preplant incorporated, and preemergence applications. At this rate, one ECO-PAK[®] water soluble packet will treat 2.5 acres.

APPLICATION INSTRUCTIONS

PrePlant and Preplant Incorporated Applications:

Apply PURSUIT W DG at the broadcast rate of 1.1 ounces per acre within 30 days before planting. (1 soluble packet treats 2.5 acres). If incorporated, DO NOT incorporate deeper than 3 inches.

Preemergence Applications:

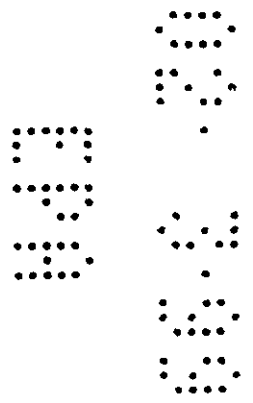
Apply PURSUIT W DG at the broadcast rate of 1.1 ounces per acre after planting, but prior to crop emergence.

PURSUIT W DG may be tank-mixed with Sencor¹ DF or Lexone² DF to assist in the control of lambsquarters or mayweed-chamomile (dogfennel). Refer to the Sencor or Lexone label for proper application rates and restrictions. Always use in accordance with the more restrictive label restrictions and precautions.
