5. On page 4 remove the statement "but not limited to." from the  $5^{th}$  paragraph entitled "Around Structures."

6. On page 4 remove the statement "but not limited to." from the first paragraph after the title "Indoor Use Directions."

7. On page 5 the second paragraph remove the statement that not limited to," from the use site descriptions.

8. On page 5 the 3<sup>rd</sup> paragraph "Not for use in edible product areas of USDA meat and poultry plants." must be changed to state: "Not for use in edible product areas of federally inspected meat and poultry processing plants."

9. On page 4 insert the bracketed disclaimer "(excluding runs and ranges) after the words "poultry houses." At the end of the same sentence aid an additional sentence stating: "Avoid direct exposure to animals to Amdro granules."

10. Remove the hyphen between word "big-headed" wherever it is identified on the label. This and species is identified as bigheaded ants.

11. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.




