DIRECTIONS FOR USE:

Use as a spot application only in places specified in these directions. Spray infested surfaces only until wet. Do not spray in the air. Do not use on plants.

Food Handling Establishments: Places other than private residences in which exposed food is held, processed, prepared or served.

Food Areas — application limited to crack and crevice treatment only. Includes areas for receiving, storage, packing (canning, bottling, wrapping, boxing), preparing edible waste, storage and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas when food is exposed and facility is in operation (also would be considered a food area).

Apply **Formula 120** in small amounts directly into cracks and crevices using equipment capable of delivering a pin stream of insecticide where roaches, waterbugs and silverfish hide, in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases, conduits, motor housing, junction or switch boxes. Prior to application de-energize electrical equipment. After application allow time for oil to evaporate before starting motors or placing switches in the on position.

Aids in the control of pantry pests (exposed stages of sawtooth grain beetle, flour beetle, rice weevil, cigarette beetle, drugstore beetle, and indian meal moth) which come in contact with treated surfaces.

Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

APPLICATIONS OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A CRACK AND CREVICE TREATMENT ARE NOT PERMITTED.

Serving Areas — Facilities where prepared foods are served, such as dining rooms, but excluding areas where foods may be prepared or held.

Apply **Formula 120** as a spot treatment to selective surfaces such as baseboards, under elements of construction, into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed.)

Non-Food Areas — Includes garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets, and storage (after canning or bottling).

Apply **Formula 120** as a spot treatment to baseboard areas around water pipes, surfaces behind and beneath sinks, lockers, tables, pallets and similar areas where insects hide or through which they may enter.

Roaches, Ants, Waterbugs, Silverfish, Sowbugs, Springtails, Spiders, Firebrats, Crickets, Earwigs: Spray until wet surfaces behind and beneath cabinets, refrigerators, sinks, stoves, ant trails and other localized areas infested with insects. Spray window sills and door frames where ants enter. Repeat as necessary.

Carpet Beetles: Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks and infested areas of shelving in closets. Repeat as necessary.

Brown Dog Ticks: Spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of pets and localized areas of floors and floor coverings. Repeat as necessary. Bedding should be replaced in animal quarters after treatment. Do not treat animals.

Flies, Mosquitoes, Wasps and Flying Moths — OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surface of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate. For wasps, spray the nest after dark when all insects have returned to the nest.

Ants, Clover Mites — OUTDOORS: For treatment of localized infestations of insects in outdoor areas where there is no vegetation, spray infested areas. For ants, wet hills and runways. Repeat as necessary.

Chiggers and Brown Dog Ticks — OUTDOORS: For treatment of localized infestations of insects, spray weeds and brushy meadow areas. Repeat as necessary.

Container Disposal: Do not reuse this container. Destroy by perforating, crushing, burning or discard in a safe place away from water supplies.
