DIRECTIONS — DISINFECTANT

To emulsify for use add 60 parts lukewarm water into disinfectant for best mixing. Apply solution to all infected areas are thoroughly covered. Use FOR URINALS: Use solution daily for regular cleaning. Pour solution into drains for further cleaning and deodorizing. FOR TOILET BOWLS: Wash seat, flush ring, bowl. After use pour remaining solution into toilet for deodorizing.

IN PUBLIC PLACES: Schools, hotels, theaters, hospitals, etc. Clean thoroughly on daily basis for maximum protection, use disinfectant.

DIRECTIONS — CLEANING AND DEODORIZING WHERE DISINFECTION IS NOT REQUIRED

Areas to be treated should be swept clean of dust. FOR NORMAL CLEANING AND DEODORIZING: Use disinfectant to regular cleaner. For best deodorizing use disinfectant on regular schedule.

FOR DAMP SWEEPING: Sprinkle or spray over area to be swept. Add 120 parts water, then sweep. Solution may be used on floor before using.

ADDED USES

FOR VENTILATORS: Add up to 1 gallon of disinfectant to regular cleaner.

CAUTIONS: HARMFUL IF SWALLOWED

Avoid contact with skin and eyes as irritation. If contact with eyes, flush liberally with clear water. Should be used with caution. Disinfectant is not intended for use as a germicide. Disinfectant not for use on humans or pets. Keep away from foodstuffs and animals.

DIRECTIONS — DISINFECTING

To emulsify for use add 60 parts lukewarm water to 1 part disinfectant. Pour water into disinfectant for best mixing. Apply solution using mop, cloth or brush, so that all infected areas are thoroughly covered. Use this dilution for application below.

FOR URINALS: Use solution daily for regular cleaning. After use pour remaining solution into drains for further cleaning and deodorizing.

FOR TOILET BOWLS: Wash seat, flush ring, bowls and adjacent areas in the solution. After use pour remaining solution into bowl, then flush for added drain deodorizing.

IN PUBLIC PLACES: Schools, hotels, theaters, stores, office areas - Wash thoroughly on daily basis for maximum protection, using above solution.

DIRECTIONS — CLEANING AND DEODORIZING WHERE DISINFECTION IS NOT REQUIRED

Areas to be treated should be swept clean of dust, dirt, etc.

FOR NORMAL CLEANING AND DEODORIZING: Add approximately 1 to 3 ounces disinfectant to regular cleaner. For best deodorizing action wash areas on regular schedule.

FOR DAMP SWEEPING: Sprinkle or spray over area with solution, 1 part disinfectant to 120 parts water, then sweep. Solution may be added to regular sweeping compound before using.

ADDED USE

FOR VENTILATORS: Add up to 1 gallon of disinfectant to tank of air washing equipment.

CAUTIONS: HARMFUL IF SWALLOWED

Avoid contact with skin and eyes as irritation may result. If spilled on skin or eyes, flush liberally with clear water. Should irritation occur consult physician. Disinfectant is not intended for use as a germicide or antiseptic.
