

For use in homes, bakeries and restaurants. Also popular for use in stores, markets, hotels, motels, dairier, canneries, breweries, meat packing plants, where foods or foodstuffs are handled.

### DIRECTIONS FOR USE

Always shake can well before spraying. Hold container upright.

To Kill Flies, Mosquitoes, Small Flying Moths, and Gnats: This formula is most effective when you spray directly on thes and flying insects. You can also clear an average size room (1000 cubic feet) of annoying insects in a matter of minutes, by simply spraying upward with a sweeping movement, keeping about 3 feet from walls, fabrics, and furniture, until the room is filled with mist (4 seconds spray time for 1000 cubic feet). Keep doors and windows closed for about 15 minutes.

- Sweep up and destroy fallen insects. Repeat treatment as necessary.

To Kill Roaches, Waterbugs and Crickets: Spray hiding places, such as baseboards and ripor boards, moist places, openings around sinks, drains and pipes, behind bookcases, cabinets and other storage areas, hitting as many insects as necessary.

Ants: Spray trails, hills, around windows and door frames and openings around pipes and baseboards where ants crawl, hitting as many - possible. Repeat applications as necessary.

Will not stain nor damage fabrics and draperies. Leaves a clean, pleasant smell.

## CAUTION: KEEP OUT OF REACH OF CHILDREN.

When used in an enclosed area do not remain in treated areas. Ventilate the area after treatment is completed. Remove pets, birds and cover fish aquariums before spraying.

If used in a food processing or preparation area, foods should be removed or covered during treatment. Food processing surfaces should be covered during treatment or thoroughly cleaned before re-use. Do not treat while food processing is underway.
