The amendment referred to above, submitted in connection with the Label Improvement Program Notice for Antimicrobial Products Used as Food Contact Surface Sanitizers, is acceptable provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling.
 - a. On the left panel, first sentence, delete the term "sanitizer."
 - b. Sodium carbonate should be deleted from the active ingredients in the ingredient statement and included with the inert ingredients.
 - c. Under the USE DIRECTIONS heading add the following misuse statement:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.
 - d. Expand the directions to include a contact time of at least 10 minutes.
 - e. Delete the entire Phenol Coefficients claim.

This product is a cleaner, virucide, disinfectant and sanitizer designed for institutional use, such as hospitals, nursing homes and schools where housekeeping is of prime importance in controlling the hazard of cross infection from inanimate surfaces. For use on floors, walls, sink tops, garbage pails, telephones, rest rooms, bed pans and operating rooms and other environmental surfaces. *Effective against Influenza A2 (Flu Virus), Herpes Simplex (cold sores, fever blisters), Adenovirus Type Z (acute respiratory disease) and Vaccinia (smallpox) viruses in addition to Staphylococcus Aureus, Salmonella Choleraesuis, and Pseudomonas Aeruginosa on environmental surfaces. Also effective against pathogenic fungi, Trichophyton interdigitale (cause of Athlete's foot) on environmental surfaces.

DANGER — Keep Out of Reach of Children. Corrosive - causes severe eye and skin damage. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and protect skin when handling. Harmful or fatal if swallowed. Avoid contamination of food.
