Spring Grain			
Annual broadleaf weeds	1.2 - 2.1	8 or more	Apply after grain is fully tillered (about 4-8" high) but not forming joints in the stem.
Perennial broadleaf weeds	1 - 2.1	8 or more	Apply when weeds are near bud stage. Do not spray grain in boot to dough stage.

*Use the lower rate if small annual and biennial weeds are the major problem. Use the higher rate if perennial weeds or annual and biennial weeds are present which are in the hard to kill categories as determined by local experience. The higher rates increase the risk of grain injury and should be used only where the weed control problem justified the grain damage risk.

Do not forage or graze treated grain fields within 2 weeks after treatment with 2,4-D. Do not feed treated straw to livestock.

WEEDS IN FALLOW LAND.	1.1 - 1.5	For annual broadleaf weeds: Spray when these weeds are young and growing vigorously.
GRASS PASTURES	2.2 - 3 pint	
	2.5 to 4 pint	For perennial broadleaf weeds: Spray when these weeds are actively growing and near the bud stage. Repeat applications may be needed for complete control. Do not graze dairy animals for seven days after spraying pastures with this product.

Do not apply to waterways. Do not apply to water after treatment if the chemical has disappeared from the soil.

Aerial spraying is a specialized job. Secure qualified pilots, aircraft, tanks and employ a competent reliable applicator. Be conversant with state laws governing the use of herbicides.

TO PREPARE A SPRAY: Add one half the required amount of water to the spray tank. Then add the product with agitation. Add the balance of water with continued agitation. This product forms an emulsion in water. Do not allow the emulsion to separate or stand. Provide agitation to prevent such separation and insure a uniform spray. Measure the use of water per acre to provide adequate coverage.

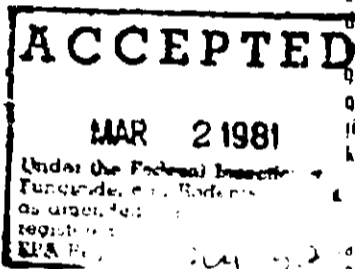
