DIRECTIONS

To control mixed brush on utility rightsof-way, spray in the spring after hardwoods have developed full sized leaves.

Where root suckering species such as sumac, sassafras, ailanthus, locust, and black gum predominate, mix 3 gallons of ENVERT-T with 9 gallons of water for each acre to be sprayed.

Where hard-to-kill species such as red maple, ash, basswood, elm or oak are present, mix 5 to 6 gallons of ENVERT-T with 15 to 18 gallons of water for each acre to be sprayed.
