

Dear Ms. Larochelle:

The labeling referred to above submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following comments:

- 1) The revised wording for turfgrass must be as follows: "Turfgrass: Liquid, wettable powder, and dry flowable labels for turfgrass must limit broadcast application to turfgrass on golf courses, sod farms, cemeteries, and commercial landscapes. Applications to other turfgrass or lawns must be limited to spot treatments of less than 1000 square feet."
- 2) Move the statement "Do not contaminate water, food or feed by storage or disposal" from the Pesticide Disposal to under the main heading of Storage and Disposal.

A stamped copy "accepted with comments" of the label is enclosed for your records. Please submit two (2) copies of the final printed label for our records before releasing the product to market. If you have any questions please call me at (703) 308-8328.
