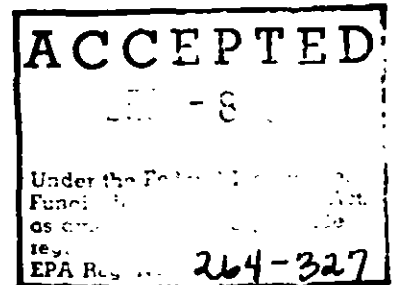

WARNING

STATEMENT OF PRACTICAL TREATMENT

GENERAL

Contact a physician immediately in all cases of suspected poisoning. Transport to a physician or hospital immediately and **SHOW A COPY OF THIS LABEL TO THE PHYSICIAN.**

IF SWALLOWED: If patient is conscious and alert, give 2-3 glasses of water or milk to drink. If available, give one tablespoon of Syrup of Ipecac to induce vomiting. If vomiting has not occurred in 20 minutes, the same dose of Syrup of Ipecac may be repeated one additional time.

Alternatively, induce vomiting by touching back of throat with finger. Do not make an unconscious person vomit. **GET MEDICAL ATTENTION.**

IF IN EYES: Flush eyes with plenty of water. Get medical attention if irritation persists.

IF ON SKIN: Wash thoroughly with soap and water.

IF INHALED: Move from contaminated atmosphere and call a physician.

NOTE TO PHYSICIAN

Carbaryl is a carbamate insecticide, which is a cholinesterase inhibitor. Overexposure to this substance may cause toxic signs and symptoms due to stimulation of the cholinergic nervous system. These effects of overexposure are spontaneously and rapidly reversible.

Specific treatment consists of parenteral atropine sulfate. Caution should be maintained to prevent overatropinization. Mild cases may be given 1 to 2 mg intramuscularly every 10 minutes until full atropinization has been achieved and repeated thereafter whenever symptoms reappear. Severe cases should be given 2 to 4 mg intravenously every 10 minutes until fully atropinized, then intramuscularly every 30 to 60 minutes to maintain the effect for at least 12 hours. Dosages for children should be appropriately reduced. Complete recovery from overexposure is to be expected within 24 hours.

Narcotics and other sedatives should not be used. Further, drugs like 2-PAM (pyridine-2-aldoxime methiodide) are NOT recommended unless organophosphate intoxication is also suggested.

To aid in confirmation of a diagnosis, urine samples should be obtained within 24 hours of exposure and immediately frozen. Analyses will be arranged by Rhône-Poulenc Ag Company.

ENVIRONMENTAL HAZARDS

This pesticide is extremely toxic to aquatic invertebrates. Do not discharge into lakes, streams, ponds, or public waters except in accordance with a NPDES permit. For further guidance, contact your Regional Office of the Environmental Protection Agency.

STORAGE AND DISPOSAL

STORAGE

Store unused product in original container only, in cool, dry area out of reach of children and animals. Do not store in areas where temperatures frequently exceed 100°F (38°C).

In case of minor spills, clean up immediately. Sweep up and dispose of wastes on site or in a landfill approved for pesticide use.

PESTICIDE DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL
