Maintáin continuous agitation in mix tank during mixing and application to assure a uniform suspension.

Greater accuracy in calibration and distribution will be achieved by injecting a larger volume of a more dilute solution per unit time.

The system must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the imigation pipeline to prevent water source contamination from backflow. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump. 


