Specific treatment consists of parenteral atroping sulfate. Caution should be maintained to prevent overatropinization. Mild cases may be given 1 to 2 mg intramuscularly every 10 minutes until full atropinization has been achieved and repeated thereafter whenever symptoms reappear. Severe cases should be given 2 to 4 mg intravenously every 10 minutes until fully atropinized, then intramuscularly every 30 to 60 minutes to maintain the effect for at least 12 hours. Dosages

for children should be appropriately reduced. Complete recovery fibm overexposure is to be expected within 24 hours.

#### GENERAL DIRECTIONS

SPRAY PREPARATION. TO ASSURE A UNIFORM PRODUCT, AGITATE OR SHAKE ALL CONTAINERS OF LARVIN® SC INSECTICIDE PRIOR TO USE Periove oil, rust, scale, pesticide residues and other foreign matter from sprayer and strainer. Flush with clean water. Use 50 mesh screens or slotted strainers in spray system. To prepare for spraying, fill tank approximately onehalf full of water. Add LARVIN SC insecticide and mix thoroughly by mechanical or hydraulic agitation. Finish filling tank with water to desired volume and throughly mix. Do not store spray mixture for prolonged periods. If tank mixes are to be used, LARVIN SC insecticide must be fully dispersed in water first, followed by the addition of the intended tank-mix material.

Start mechanical or hydraulic agitation. Add the required amount of LARVIN® SC, and then the remaining volume of water. (Suspension concentrations using the appropriate dosage per acre recommended on this label of LARVIN® SC per 1 to 4 yallons of water are recommended). Then set sprinkler to deliver 0.1 to 0.3 inch of water per acre. Start sprinkler and uniformly inject the suspension of LARVIN® SC into the irrigation water line so as to deliver the desired rate per acre. The suspension of LARVIN® SC should be injected with a positive displacement pump into the main line ahead of a right angle tum to insure adequate mixing. If you should have any other questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other experts.

<u>NOTE</u>: When treatment with LARVIN® brand SC Thiodicarb Insecticide has been completed, further field irrigation over the treated area should be avoided for 24 to 48 hours to prevent washing the chemical off the crop.

# GENERAL PROCAUTIONS FOR APPLICATIONS THROUGH SPRINKLER

Maintain continuous agitation in mix tank during mixing and application to assure a uniform suspension

Greater accuracy in calibration and distribution will be achieved by injecting a larger volume of a more dilute solution per unit time.

The system must contain a functional check valve, vacuum reliet valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump. The pesticide injection pipeline must also contain a functional, normally closed solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually chutdown. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
