GENERAL:

Contact a physician immediately in all cases of suspected poisoning. breathing stops, start artificial respiration, establish an airway and coxygen. Make certain to remove all sources of continuing contamination. Remove clothing and wash skin and hair immediately with large amounts of water. Transport the patient to a physician or hospital immediately and SHOW A COPY OF THIS LABEL TO THE PHYSICIAN.

IF SWALLOWED: Drink 1 or 2 glasses of water and induce vomiting by touching the back of the throat with finger. Never give anything by mouth to an unconscious or convulsing person. Call a physician and follow General advice listed above.

NOTE TO PHYSICIAN

Thiodicarb is an oxime carbamate insecticide, which is a cholinesterase inhibitor. Overexposure to this substance may cause toxic signs and symptoms due to stimulation of the cholinergic nervous system. These effects of overexposure are spontaneously and rapidly reversible.

Specific treatment consists of parenteral atropine sulfate. Caution should be maintained to prevent overatropinization. Mild cases may be give 1 to 2 mg intramuscularly every 10 minutes until full atropinization has been achieved and repeated thereafter whenever symptoms reappear. Severe cases should be given 2 to 4 mg intravenously every 10 minutes until fully atropinized, then intramuscularly every 30 to 60 minutes to maintain the effect for at least 12 hours. Dosages for children should be appropriately reduced. Complete recovery from overexposure is to be expected within 24 hours.

Narcotics and other sedatives should not be used. Further, drugs like 2-PAM (pyridine-2-aldoxime methiodide) are NOT recommended unless organophosphate intoxication is also suggested.

To aid in the confirmation of a diagnosis, urine samples should be obtained within 24 hours of exposure and immediately frozen. Analyses will be arranged by Union Carbide Agricultural Products Company, Inc.
