Dear Dr. Barron:

The label amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable, provided that you adhere to the following requirements:

1. You must make the following changes to your proposed label:

a. In the STATEMENT OF PRACTICAL TREATMENT section, there are two IF INHALED statements. You must remove the second IF INHALED statement.

b. In the ENVIRONMENTAL HAZARDS section, remove the sentence "Do not contaminate water by cleaning of equipment or disposal of wastes."

c. You must modify the last paragraph of the LIMITED WARRANTY AND DISCLAIMER section, which begins "BUYER'S EXCLUSIVELY REMEDY AND MANUFACTURER'S OR SELLER'S EXCLUSIVE LIABILITY...", to the following language:

Manufacturer or seller expressly disclaim liability for any and all claims, losses, damages or injuries resulting from the use or handling of this product, whether or not based in contract, negligence, strict liability in tort other than, at the manufacturer's option, to replacement of, or the repayment of the purchase price for, the quantity of product with respect to which damages are claimed. Manufacturer or seller expressly disclaim liability for special, indirect or consequential damages resulting from the use or handling of this product. 2. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.
