The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

Change the first sentence of the Environmental Hazards statement to read as follows: This pesticide is toxic to birds, fish, and other aquatic and estuarine invertebrates.

Delete the heading "General Precautions..." from the directions for use. This detracts from the precautionary statements.

At your option, in accordance with PR Notice 97-5, you may use the chemical name fipronil alone in the ingredient statment, and you are not required to use the chemical name.

At your option, you may substitute the heading "First Aid" in lieu of "Statement of Practical Treatment".
