Dear Ms Larochelle:

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, to provide a revised label which: (1) corrects the chemical name; and (2) adds the same new uses that are being registered concurrently for EPA Reg. No. 432-1448 (ie. ornamentals, cut flowers, non-bearing fruit trees, in outdoor nursery and plant production facilities), is acceptable providing you submit a final printed label within 45 days from the date of this letter, which makes the following change:

Page 2 – at the top of this page, second line, change "...fruit trees, and outdoor nursery and plant production facilities" to "...fruit trees, in outdoor nursery and plant production facilities".
