Dear Mr. Barron:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended is acceptable, provided you make the following changes before you release the product for shipment.

1. Add an appropriate EPA Establishment Number to the label.
2. Remove the statements "Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse" from the PRECAUTIONARY STATEMENTS section.
3. In the section STORAGE AND DISPOSAL, add the subheading "Pesticide Disposal" before the statement "Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility." Add the subheading "Container Disposal" before the statements "Empty containers should be triple rinsed. Do not reuse empty containers. Offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities."
4. In the section STORAGE AND DISPOSAL, add a subsection titled "Pesticide Storage" with appropriate pesticide storage directions, and place after the statement "Do not contaminate water, food or feed by storage or disposal."
5. On page 2, change "should" to "must" in the statement "The directions for use of this product are believed to be adequate and should be followed carefully."
6. On page 2, add "To the extent consistent with applicable law" before the statement "All such risks shall be assumed by the user or buyer."
7. On page 2, add "To the extent consistent with applicable law" before the statements "Bayer Cropscience makes no other warranties, express or implied, of merchantability..." and "Bayer Cropscience disclaims any liability whatsoever for special, incidental or consequential damages resulting from the use or handling of this product."


- 8. On page 2, change "To the extent allowed by law" to "To the extent consistent with applicable law" in the subsection LIMITATIONS OF LIABILITY.

The basic CSF [dated 1/20/2006] will supercede all previously accepted basic CSF's and will be added to your file.
