#### Dear Mr. Mattern:

The labeling referred to above, submitted in connection with registration under section under 3(c)(7)(b) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) is acceptable provide the following changes are made:

- 1. Within the ingredients statement, add a line for the total percent amount for the active ingredient and other ingredients which reads as follows "Total ...... 100%."
- 2. On page 2, second sentence under the section "Only For Formulation Into a Fungicide, for the Following Uses" section, revise the word, "product" to "products".
- 3. On page 2, within the "Storage and Disposal" section, add the word, "secure" prior to the word, "dry" so that the sentence reads, "Store in a cool, secure, dry area."
- 4. On page 2, add the phrase, "Manufactured for" above the company name and address.

### New Conditional Data Requirements:

- 1. Submit an Immunotoxicity study (OPPTS Guideline No. 870.7800) by April 2010.
- 2. Submit a Tier II Seedling Emergence and Vegetative Vigor tests (OPPTS Guideline No. 850.4225 and 850.4250) (123-1a and b) by September 2010.
- 3. The standard for pyrimethanil at the National Pesticide Standards Repository has expired. You must either recertify the lot in the repository, and send in an updated certificate of analysis (COA), or submit a new standard (with a different lot number) if the previous lot can not be recertified. If a new COA is submitted, you may fax the documentation to the repository at (410)305-2999 or you may mail it to the address below.

### Remaining Conditional Data Requirements identified in the 8/13/2004 Registration Notice:

- 1. Submit a Mouse Carcinogenicity study (OPPTS Guideline No. 860.4200) by March 2010.
- 2. The Agency acknowledges receipt of the Freshwater Fish Life Cycle study (OPPTS Guideline No.850.1500), MRID No. 475169-01 and notes the review is pending.
- 3. The Agency notes the Estaurine/Marine Fish Early Life Stage study (OPPTS Guideline 850.1400) is reserved. This data may be required at a later date pending review of the Freshwater Fish Life Cycle study.
- 4. The Agency acknowledges receipt of production information for 2005-2008.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e).
