2) Add the following to the spray drift section "(In general, a decrease in droplet size or increase in wind speed at the time of application will result in risk to non-target organisms. Alternatively, if droplet size is coarser or wind speeds are lower, exposures due to drift would be reduced)."

3) The general prohibition "DO NOT APPLY BY AIR IF SENSITIVE NON-TARGET CROPS ARE WITHIN 100 FEET OF THE APPLICATION SITE" must be qualified with the addition of the phrase "... except as noted below for lettuce and citrus." Also, "OR CANTALOUPE" appears in the subheading, "CARE SHOULD BE TAKEN WHEN APPLYING GINSTAR® SC COTTON DEFOILIANT ADJACENT TO LETTUCE, CITRUS, OR CANTALOUPE" at the top of page 4 of the label. Although specific restrictions are provided for lettuce and citrus, there is no mention of special precautions when applying adjacent to cantaloupe, cantaloupes must be addressed as well.

4) Based on toxicity ranking per the acute toxicity review, the First Aid statements should be placed on the label in the following order:
