Prosaro 421 SC Fungicide is currently registered for control of certain diseases infecting barley and wheat. It contains the active ingredients prothioconazole and tebuconazole. With this application form, we are notifying the Agency that we are adding the statement "Aerial application is prohibited in New York State." This statement is now required by New York for all products containing the active ingredient tebuconazole as indicated in the enclosed copy of their May 18, 2009 letter. As indicated in the enclosed copy of Linda Arrington's 11/17/2009 e-mail, the Agency is allowing this type of change by notification.

As required by PR Notice 98-10, we are enclosing one copy of draft labeling, dated 11/19/09, in which the statement "Aerial application is prohibited in New York State" is highlighted in yellow on page 4. In addition, we are also enclosing two copies of final printed labeling. There are no changes in rates, timing of application, number of applications, PHI, ingredient statement, signal word, use classification, precautionary statements, statements of practical treatment (first aid), physical/chemical/biological properties, or storage and disposal from that which is currently registered.

This notification is consistent with the provision of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA, and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.

Do not contaminate water when disposing of equipment washwater or rinsate.

Groundwater Advisory: Prothioconazole-desthio (a degradate of prothioconazole) and tebuconazole are known to leach through soil into ground water under certain conditions as a result of label use. Use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in ground-water contamination.

Surface Water Advisory: This product may contaminate water through drift of spray in wind. Drift and runoff are hazardous to aquatic organisms in water adjacent to treated areas. This product has a high potential for runoff for several months or more after application. Poorly draining soils and soils with shallow watertables are more prone to produce runoff that contains this product. A level, well maintained vegetative buffer strip between areas to which this product is applied and surface water features such as ponds, streams, and springs will reduce the potential for contamination of water from rainfall-runoff. Runoff of this product will be reduced by avoiding applications when rainfall is forecasted to occur within 48 hours.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted-entry interval (REI) of 48 hours.

PPE required for early entry to treated areas that is permitted under the Worker Protection Standard and that involves contact with anything that has been treated, such as plants, soil, or water is:

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Pesticide Storage: Store in a cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food, and feed. Store in original container and out of the reach of children, preferably in a locked storage area.

Handle and open container in a manner as to prevent spillage. If container is leaking, invert to prevent leakage. If the container is leaking or material is spilled for any reason or cause, carefully dam up spilled material to prevent runoff. Refer to Precautionary Statements on label for hazards associated with the handling of this material. Do not walk through spilled material. Absorb spilled material with absorbing type compounds and dispose of as directed for pesticides below. In spill or leak incidents, keep unauthorized people away. Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Non-refillable container. Do not reuse or refill this container. Triple rinse or pressure rinse container (or equivalent) promptly after emptying.

Triple tinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank of store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

Pressure rinse as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

Offer for recycling, if available. If not recycled, then puncture and dispose of in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

Refillable container – Refer to Bottom Discharge IBC or Top Discharge IBC, Drums, Kegs information as follows. Refill this container with pesticide only. Do not reuse this container for any other purpose. Contact your Ag retailer or Bayer CropScience for container return, disposal and recycling recommendations.

Bottom Discharge IBC (e.g. - Schuetz Caged IBC or Snyder Square Stackable)

End users are authorized to remove tamper evident cables as required to remove the product from the container and to pressure rinse the container with water to remove residual product contents. Pressure rinsing the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. Empty the remaining contents from the IBC into application equipment or mix tank. Raise the bottom of the IBC by 1.5 inch on the side which is opposite of the bottom discharge valve to promote more complete product removal. Completely remove the top lid of the IBC. Use water pressurized to at least 40 PSI to rinse all interior portions. Continuously pump or drain rinsate into application equipment or rinsate collection system while pressure rinsing. Continue pressure rinsing for 2 minutes or until rinsate becomes clear. Replace the lid and close bottom valve.

Top Discharge IBC, Drums, Kegs (e.g. - Snyder 120 Next Gen, Bonar B120, Drums, Kegs).

End users are not authorized to not remove tamper evident cables, one way valves or clean container if refilling is planned. Triple rinsing the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller. To triple rinse the containers before final disposal, empty the remaining contents from this container into application equipment or mix tank. Fill the container at least 10 percent full with water. Agitate vigorously or recirculate water with the pump for 2 minutes. Rinse all interior surfaces. Pour or pump rinsate into application equipment or rinsate collection system. Repeat this procedure two more times.

GENERAL INFORMATION

PROSARO[™] 421 SC Fungicide is a broad-spectrum systemic fungicide for the control of Ascomycetes, Basidiomycetes and Deuteromycetes diseases in barley and wheat. Under conditions conducive to extended infection periods or high disease pressure, another registered fungicide may be needed once this product's maximum application rates have been reached. Under these conditions use another fungicide registered for the crop/disease.

Resistance Management Statement

PROSARO™ 421 SC Fungicide is a Group 3 fungicide which exhibits no known cross-resistance to other fungicide groups. However, fungal pathogens are known to develop resistance to products with the same mode of action when used repeatedly. Any fungal population may contain or develop individuals that are resistant to PROSARO™ 421 SC and other Group 3 fungicides. If Group 3 fungicides are used repeatedly in the same field or in successive years as the primary method of control for targeted diseases, the resistant isolates may eventually dominate the fungal population. Because resistance development cannot be predicted, the use of this product should conform to resistance management strategies established for the crop and use area. Such strategies may include rotation and /or tank mixing with products having different modes of action or limiting the total number of applications per season. Contact your local extension specialist, certified crop advisor, and/or manufacturer for fungicide resistance management and/or integrated disease management directions for specific crops and pathogen populations. Bayer CropScience encourages responsible resistance management to ensure effective long-term control of the fungal diseases on this label.

Spray Equipment/Volumes

PROSARO 421 SC FUNGICIDE may be applied by either ground, aerial and/or chemigation application equipment. Equipment must be properly calibrated before use.

For ground application, apply in a minimum of 10 gallons of spray solution per acre. For aerial application, apply in a minimum of 2 gallons of spray solution per acre unless stated differently in the USE DIRECTIONS FOR SPECIFIC CROPS section. Check equipment calibration frequently. Complete coverage and uniform application are essential for the most effective results, especially when lower spray volumes are applied. If necessary, increase the spray volume per acre for complete crop coverage.

Mixing Procedures

Prepare no more spray mixture than is necessary for the immediate operation. Thoroughly clean spray equipment before using this product. Maintain maximum agitation throughout the spray operation. Do not let the spray mixture stand overnight in the spray tank. Flush the spray equipment thoroughly following each use and apply the rinsate to the previously treated area or dispose of the rinsate according to local regulations. Do not tank mix with products containing a prohibition against tank mixing. Follow the most restrictive labeling requirements of any tank mix product.

PROSARO 421 SC FUNGICIDE Alone: Add ½ of the required amount of water to the mix tank. With the agitator running, add the PROSARO 421 SC FUNGICIDE to the tank. Continue agitation while adding the remainder of the water. Begin application of the solution after the product has completely and uniformly dispersed into the mix water. Maintain agitation until all of the mixture has been applied.

PROSARO 421 SC FUNGICIDE + Tank-Mix Partners: Add ½ of the required amount of water to the mix tank. Start the agitator running before adding any of the tank-mix partners. In general, tank-mix partners should be added in this order: products packaged in water-soluble packaging*, wettable powders, wettable granules (dry flowables), liquid flowables, liquids and emulsifiable concentrates. Always allow each tank-mix partner to become fully and uniformly dispersed before adding the next product. Provide sufficient agitation while adding the remainder of the water. Maintain agitation until all of the mixture has been applied.

* Note: When using PROSARO 421 SC FUNGICIDE in tank mixtures, all products in water-soluble packaging should be added to the tank before any other tank-mix partner, including PROSARO 421 SC FUNGICIDE. Allow the water-soluble packaging to completely disperse before adding any other tank-mix partner to the tank.

If using PROSARO 421 SC FUNGICIDE in a tank mixture, observe all directions for use, crop/sites, use rates, dilution ratios, precautions, and limitations; which appear on the tank-mix product label. No label dosage rate must be exceeded, and the most restrictive label precautions and limitations must be followed. This product must not be mixed with any product that prohibits such mixing. Tank mixtures or other applications of products referenced on this label are permitted only in those states in which the referenced products are registered.

PROSARO 421 SC FUNGICIDE is compatible with most insecticide, fungicide, herbicide and foliar nutrient products. However, the physical compatibility of PROSARO 421 SC FUNGICIDE with tank-mix partners should be tested before use. To determine the physical compatibility of PROSARO 421 SC FUNGICIDE with other products, use a jar test, as described below.

Using a quart jar, add the proportionate amounts of the products to 1 qt. of water. Add wettable powders and water-dispersible granular products first, then liquids, and emusifiable concentrates last. After thoroughly mixing, let stand for at least 5 minutes. If the combination remains mixed or can be remixed readily, it is physically compatible. Once compatibility has been proven, use the same procedure for adding required ingredients to the spray tank. For further information contact your local Bayer CropScience representative.

The crop safety of all potential tank mixes including additives and other pesticides on all crops has not been tested. Before applying any tank mixture not specified on this label, the safety to the target crop should be confirmed. To test for crop safety, apply PROSARO 421 SC FUNGICIDE to the target crop in a small area and in accordance with label instructions for the target crop.

Aerial Application: Avoid application under conditions when uniform coverage cannot be obtained or when excessive spray drift may occur. Do not apply directly to humans or animals. Aerial application is prohibited in New York State.

Chemigation Application: Apply PROSARO 421 SC FUNGICIDE through irrigation equipment only to crops for which chemigation is specified on this label.

PROSARO 421 SC FUNGICIDE alone or in combination with other pesticides which are registered for application through irrigation systems, may be applied through irrigation systems. Apply this product only through center pivot, solid set, hand move, or moving wheel irrigation systems. Do not apply this product through any other type of irrigation system. Illegal pesticide residues in the crop can result from nonuniform distribution of treated water. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers, or other experts. Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system, unless the pesticide label-prescribed safety devices for public water systems are in place. A person knowledgeable of the chemigation system and responsible for its operation, or under the supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.

Operating Instructions

- 1. The system must contain a functional check-valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water-source contamination from backflow.
- 2. The pesticide injection pipeline must contain a functional, automatic, quick-closing check-valve to prevent the flow of fluid back toward the injection pump.
- 3. The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.

- 4. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
- 5. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
- 6. Systems must use a metering pump, such as a positive displacement injection pump (e.g.,diaphragm pump), effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
- 7. Do not apply when wind speed favors drift beyond the area intended.

Center Pivot Irrigation Equipment

Notes: (1) Use only with drive systems which provide uniform water distribution. (2) Do not use end guns when chemigating PROSARO 421 SC FUNGICIDE through center pivot systems because of non-uniform application.

Determine the size of the area to be treated. Determine the time required to apply 1/8-1/2 inch of water over the area to be treated when the system and injection equipment are operated at normal pressures as recommended by the equipment manufacturer. When applying PROSARO 421 SC FUNGICIDE through irrigation equipment use the lowest obtainable water volume while maintaining uniform distribution. Run the system at 80-95% of the manufacturer's rated capacity. Using water, determine the injection pump output when operated at normal line pressure. Determine the amount of PROSARO 421 SC FUNGICIDE required to treat the area covered by the irrigation system. Add the required amount of PROSARO 421 SC FUNGICIDE and sufficient water to meet the injection time requirements to the solution tank. Make sure the system is fully charged with water before starting injection of the PROSARO 421 SC FUNGICIDE solution. Time the injection to last at least as long as it takes to bring the system to full pressure. Maintain constant solution tank agitation during the injection period. Continue to operate the system until the PROSARO 421 SC FUNGICIDE Fungicide solution has cleared the sprinkler head.

Solid Set, Hand Move, and Moving Wheel Irrigation Equipment

When applying PROSARO 421 SC FUNGICIDE through irrigation equipment use the lowest obtainable water volume while maintaining uniform distribution. Determine the amount of PROSARO 421 SC FUNGICIDE required to treat the area covered by the irrigation system. Add the required amount of PROSARO 421 SC FUNGICIDE into the same quantity of water used to calibrate the injection period. Operate the system at the same pressure and time interval established during the calibration. Stop injection equipment after treatment is completed. Continue to operate the system until the PROSARO 421 SC FUNGICIDE solution has cleared the last sprinkler head.

Adjuvants: PROSARO 421 SC FUNGICIDE is recommended to be used with a registered non-ionic surfactant at the lowest specified labeled rate.

Directions to Avoid Spray Drift
