## DIRECTIONS FOR USE

### GENERAL INFORMATION

RTU-Trifloxystrobin-Metalaxyl Flowable provides seed and seedling protection against seedborne fungi causing seed decay and the soilborne pathogens, *Rhizoctonia solani* and *Pythium* spp. causing seed and seedling damping-off. RTU-Trifloxystrobin-Metalaxyl Flowable Fungicide is a ready-to-use seed treatment especially formulated for on-farm equipment for direct application, or may be applied using standard slurry or mist-type seed treatment equipment. Consult a seed treatment specialist for proper guidelines in using RTU-Trifloxystrobin-Metalaxyl Flowable Fungicide to insure uniform coverage of seed, thus ensuring seed safety and best disease protection.

### USE PRECAUTIONS

When using formulations that do not contain dye, to comply with 40 CFR 153.155, all seed treated with an economic poison must be colored to distinguish it and prevent subsequent inadvertent use as a food for man or feed for animals.

### USE RESTRICTION

Do not use treated seed for food, feed, or oil processing.
