With the Agency's April 2, 2009 letter (copy enclosed) the Agency approved our October 21, 2008 application (EPA Decision No. 4020878) to add use on almonds, pistachio, pome fruit, stone fruit, and tree nuts to our Adament 50 WG Fungicide label. Part of the conditions of registration were that Bayer CropScience delete the words "and higher rates" for the diseases Phomopsis cane & leaf spot and black rot in the application instruction table for grapes. This was done and final printed labeling was submitted to the Agency on April 7, 2009.

The California Department of Pesticide Regulation has since noticed that in the same application instruction table for grapes, the words "and higher rates" should also have been removed for the disease Botrytis bunch rot. Therefore, with the enclosed application form we are notifying the Agency that "and higher rates" is being removed from the applications instruction table for the disease Botrytis bunch rot infecting grapes.

Since this is a notification, no fee is required under PRIA II.



With the Agency's April 2, 2009 letter (copy enclosed) the Agency approved our October 21, 2008 application (EPA Decision No. 4020878) to add use on almonds, pistachio, pome fruit, stone fruit, and tree nuts to our Adament 50 WG Fungicide label. Part of the conditions of registration were that Bayer CropScience delete the words "and higher rates" for the diseases Phomopsis cane & leaf spot and black rot in the application instruction table for grapes. This was done and final printed labeling was submitted to the Agency on April 7, 2009.

The California Department of Pesticide Regulation has since noticed that in the same application instruction table for grapes, the words "and higher rates" should also have been removed for the disease Botrytis bunch rot. Therefore, we are notifying the Agency that "and higher rates" is being removed from the applications instruction table for the disease Botrytis bunch rot infecting grapes (see page 6 of the enclosed redlined draft label). In addition to the redline copy of draft labeling showing the text to be deleted, we are also including two copies of final printed labeling, dated 04/02/09, Notification 05/20/09, in which "and higher rates" has been removed. There are no other changes in the labeling from that which is currently registered.

This notification is consistent with the provision of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA, and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.

Several trifloxystrobin degradates have properties and characteristics associated with chemicals detected in ground water. The use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in ground water contamination.

Tebuconazole is known to leach through soil into ground under certain conditions as a result of label use. Use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in ground-water contamination.

Surface Water Advisory:

This product may contaminate water through drift of spray in wind. This product has a high potential for runoff for several months or more after application. Poorly draining soils and soils with shallow water tables are more prone to runoff that contains this product. A level, well maintained vegetative buffer strip between areas to which this product is applied and surface water features such as ponds, streams, and springs will reduce the potential for contamination of water from rainfall-runoff. Runoff of this product will be reduced by avoiding applications when rainfall is forecasted within 48 hours.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Do not use this product until you have read the entire label.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.

For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted-entry interval (REI) of 12 hours unless otherwise noted in the crop application directions.

PPE required for early entry to treated areas that is permitted under the Worker Protection Standard and that involves contact with anything that has been treated, such as plants, soil, or water, is:

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Pesticide Storage

Store in a cool, dry place and in such a manner as to prevent cross-contamination with other pesticides, fertilizers, food, and feed. Store in original container and out of the reach of children, preferably in a locked storage area.

Handle and open container in a manner as to prevent spillage. If container is leaking or material spilled for any reason or cause, carefully sweep material into a pile. Refer to Precautionary Statements on label for hazards associated with the handling of this material. Do not walk through spilled material. Dispose of pesticide as directed. Pesticide Disposal

Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal

Non-refillable container. Do not reuse or refill this container. Triple rinse or pressure rinse container (or equivalent) promptly after emptying.

Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

Pressure rinse as follows: Empty the remaining contents into application equipment or a mix tank. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

Offer for recycling, if available. If not recycled, then puncture and dispose of in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

GENERAL INFORMATION

ADAMENT® 50 WG Fungicide is a broad spectrum fungicide for the control of certain diseases of almonds, grapes, pistachio, pome fruit, stone fruit and tree nuts. ADAMENT 50 WG Fungicide works by interfering with both energy and cell membrane production in plant pathogenic fungi.

UNDER CERTAIN CONDITIONS CONDUCIVE TO EXTENDED INFECTION PERIODS, ADDITIONAL FUNGICIDE APPLICATIONS BEYOND THE NUMBER ALLOWED BY THIS LABEL MAY BE NEEDED. UNDER THESE CONDITIONS, USE ANOTHER FUNGICIDE REGISTERED FOR THE CROP/DISEASE.

DO NOT APPLY ADAMENT TO CONCORD GRAPES OR CROP INJURY MAY OCCCUR.

RESISTANCE MANAGEMENT

The active ingredients in ADAMENT 50 WG Fungicide belong to two different chemistry classes.

Tebuconazole belongs to the DMI (Group 3) class of chemistry which exhibits no known cross-resistance to other chemical classes. Tebuconazole may exhibit cross-resistance to other Group 3 fungicides, such as propiconazole and myclobutanil.

Trifloxystrobin belongs to the QoI (Group 11) class of chemistry which exhibits no known cross-resistance to other chemical classes. Trifloxystrobin does exhibit cross-resistance to other Group 11 fungicides, such as azoxystrobin, pyraclostrobin, and kresoxim-methyl. The NA-QoI Working Group has established the following general guidelines for the maximum number of applications of a Group 11-containing fungicide. In addition to that, the maximum number of applications may be restricted to a specific limit on a particular crop (see crop-specific recommendations). Follow the specific crop directions that limit the total number of sprays on a crop and the required alternations with fungicides from other resistance management groups. In situations requiring multiple fungicide sprays, develop season-long spray programs for Group 11-containing fungicides. In programs in which pre-mixes of a Group 11 fungicide with a fungicide of another group are utilized, the number of Group 11-containing applications should be no more than about 1/2 of the total number of fungicide applications per season.

Fungal pathogens are known to develop resistance to products with the same mode of action when used repeatedly. Because resistance development cannot be predicted, the use of this product should conform to resistance management strategies established for the crop and use area. Such strategies may include rotating and/or tank mixing with products having different modes of action or limiting the total number of applications per season. Bayer CropScience encourages responsible resistance management to ensure effective long-term control of the fungal diseases on this label.

SPRAY EQUIPMENT

Thorough coverage is necessary to provide good disease control. Applications using sufficient water volume to provide thorough and uniform coverage generally provide the most effective disease control. For ground application equipment, use a minimum of 10 gal./A. For aerial application equipment, use a minimum of 5 gal./A.



Broadcast Ground Sprayers

Equip sprayers with nozzles that provide accurate and uniform application. Be certain that nozzles are the same size and uniformly spaced across the boom. Calibrate the sprayer before use.

Use a pump with the capacity to: (1) maintain a minimum of 35 psi at nozzles, and (2) provide sufficient agitation in the tank to keep the mixture in suspension; this requires recirculation of 10% of the tank volume per minute. Use jet agitators or a liquid sparge tube for vigorous agitation.

·Use screens to protect the pump and to prevent nozzles from clogging. Screens placed on the suction side of the pump should be 16-mesh or coarser. Do not place a screen in the recirculation line. Use 50-mesh screens at the nozzles. Check nozzle manufacturer's recommendations.

For information on spray equipment and calibration, consult sprayer manufacturer's and/or state recommendations. For specific local spray schedules, consult the current state agricultural experiment station recommendations.

AERIAL APPLICATION

Avoid application under conditions when uniform coverage cannot be obtained or when excessive spray drift may occur. Do not apply directly to humans or animals. Not registered for aerial application in New York State.

CHEMIGATION

Do not apply this product through any type of irrigation system.

MIXING PROCEDURES

Prepare no more spray mixture than is needed for the immediate operation. Thoroughly clean spray equipment before using this product. Vigorous agitation is necessary for proper dispersal of the product. Maintain maximum agitation throughout the spraying operation. Do not let the spray mixture stand overnight in the spray tank. Flush the spray equipment thoroughly following each use and apply the rinsate to a previously treated area.

ADAMENT 50 WG Fungicide Alone: Add approximately 1/2 of the required amount of water to the mix tank. With the agitator running, add the ADAMENT 50 WG Fungicide to the tank. Continue agitation while adding the remainder of the water. Begin application of the solution after the ADAMENT 50 WG Fungicide has completely and uniformly dispersed into the mix water. Maintain agitation until all of the mixture has been applied.

ADAMENT 50 WG Fungicide + Tank Mix Partners: Add approximately 1/2 of the required amount of water to the mix tank. Start the agitator running before adding any tank mix partners. In general, tank mix partners should be added in this order: products packaged in watersoluble packaging*, wettable powders, wettable granules (dry flowables), liquid flowables such as ADAMENT 50 WG Fungicide, liquids, and emulsifiable concentrates. Always allow each tank mix partner to become fully and uniformly dispersed before adding the next product. Provide sufficient agitation while adding the remainder of the water. Maintain agitation until all of the mixture has been applied.

* Note: When using ADAMENT 50 WG Fungicide in tank mixtures, all products in water-soluble packaging should be added to the tank before any other tank mix partner, including ADAMENT 50 WG Fungicide. Allow the water-soluble packaging to completely dissolve and the product(s) to completely disperse before adding any other tank-mix partner to the tank. If using ADAMENT 50 WG Fungicide in a tank mixture, observe all directions for use, crop/sites, use rates, dilution ratios, precautions, and limitations which appear on the tank mix partner product label. No label dosage rate may be exceeded, and the most restrictive label precautions and limitations must be followed. This product must not be mixed with any product which prohibits such mixing. Tank mixtures or other applications of products referenced on this label are permitted only in those states in which the referenced products are registered.

ADAMENT 50 WG Fungicide is compatible with most insecticide, fungicide, and foliar nutrient products. However, the physical compatibility of ADAMENT 50 WG Fungicide with tank mix partners should be tested before use. To determine the physical compatibility of ADAMENT 50 WG Fungicide with other products, use a jar test, as described below.

Using a quart jar, add the proportionate amounts of the products to 1 quart of water. Add wettable powders and water-dispersible granular products first, then liquid flowables, and emulsifiable concentrates last. After thoroughly mixing, let stand for at least 5 minutes. If the combination remains mixed or can be remixed readily, it is physically compatible. Once compatibility has been proven, use the same procedure for adding required ingredients to the spray tank.

The crop safety of all potential tank mixes, including additives and other pesticides, on all crops has not been tested. Before applying any tank mixture not specifically recommended on this label, the safety to the target crop should be confirmed. To test for crop safety, apply the tank mixture to the target crop in a small area and in accordance with label instructions for the target crop.

RECOMMENDATIONS TO AVOID SPRAY DRIFT

Do not make applications when conditions favor drift beyond the target application area. When drift may be a problem, take measures to reduce drift, including:

- 1. Do not spray if wind speeds are or become excessive. Do not spray if wind speed is 15 mph or greater. If nontarget crops are located downwind, use caution when spraying if wind is present. Do not spray if winds are gusty.
- 2. Use caution when conditions are favorable for drift (high temperatures, drought, low relative humidity).



3. Do not apply when a temperature inversion exists. If inversion conditions are suspected, consult with local weather services before making an application.

RAINFASTNESS

ADAMENT 50 WG Fungicide is rainfast when dry, generally in 2 hours, and dependent on local weather conditions, such as humidity and wind.

USE DIRECTIONS FOR SPECIFIC CROPS

ADAMENT 50 WG Fungicide provides control or suppression of several important diseases of almonds, grapes, pistachio, pome fruit, stone fruit and tree nuts. When reference is made to disease suppression, suppression can mean either erratic control from good to fair, or consistent control at a level below that obtained with the best commercial disease control products.

Restrictions:

Do not apply more than 32 oz. of ADAMENT 50 WG FUNGICIDE per acre per season. Do not make more than 4 total applications of ADAMENT 50 WG FUNGICIDE per season. Do not apply ADAMENT 50 WG FUNGICIDE within 60 days of harvest or after hull split. Do not cut cover crops in treated areas for feed, or allow livestock to graze treated areas. ADAMENT 50 WG FUNGICIDE is a mixture of a Group 11 and a Group 3 fungicide. To limit the potential for the development of resistance, do not apply more than 2 sequential applications of ADAMENT 50 WG FUNGICIDE or other Group 11-containing fungicides.
