GENERAL INFORMATION

Trilex AL Concentrate provides seed and seedling protection against seedborne fungi causing seed decay and soilborne pathogens, *Rhizoctonia solani*, *Fusarium* spp., and *Pythium* spp. that cause seed and seedling damping-off. Trilex AL Concentrate can be used for suppression of early season *Phytophthora* seed and root rot. Trilex AL Concentrate is a concentrated formulation especially formulated for application using standard slurry or mist-type seed treatment equipment. Consult a seed treatment specialist for proper guidelines in using Trilex AL Concentrate to insure uniform coverage of seed, thus ensuring seed safety and best disease protection. For commercial and on-farm use.

USE PRECAUTIONS



Areas planted with treated seed may be replanted immediately with any crop for which a tolerance exists for trifloxystrobin. Do not plant any crop without trifloxystrobin tolerances until 30 days after planting trifloxystrobin treated seed.
