Dear Christie Villegas:

The application referred to above, submitted under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable under FIFRA section 3(c)(5).

You must submit and/or cite all data required for registration/registration/registration review of your product when the Agency requires all registrants of similar products to submit such data.

During the review of this action, it was noted that an analytical reference standard is currently available for this technical; however, a standard of the isotopically-labeled IS (BCS-CL73507-13C2, D3) is not available and must be submitted within 6 months from the date of this letter.

Please submit each gram of analytical standard in 10 aliquot vials of 100 mg each. Each aliquot vial must be sealed, and labeled with the name of the analytical standard, percent purity, lot number and expiration date. The reference standard should be sent to the Biological and Economic Analysis Division's Analytical Chemistry Branch (BEAD/ACB), to the attention of either Craig Vigo or Thuy Nguyen at the address listed below, along with a letter of transmittal. Please note that the full 9-digit ZIP Code is required, or the mail will be returned to the registrant.

After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling.
