- 3. If, after formal consultation with the appropriate Service(s), additional modifications are identified in the Service's Biological Opinion(s) for clothianidin, EPA will notify Bayer CropScience LP in writing consistent with the terms in the Biological Opinion of any necessary required changes. Bayer CropScience LP must submit an application for amendment incorporating any required changes, including amended labels, consistent with the timeline specified in EPA's notification. If Bayer CropScience LP fails to comply with this term, Bayer CropScience LP has agreed in prior written acceptance on August 24, 2023, of these terms that EPA may cancel the registration under an expedited process under FIFRA 6(e).
- 4. Submit one copy of the final printed label for the record before you release the product for shipment.
