Dear Ms. Chavez;

The Agency in accordance with the Federal Fungicide and Rodenticide Act as Amended (FIFRA) has completed reviewing all of the information submitted with your application to support the reregistration of the aforementioned product in connection with the MGK[®] 326 RED, and have concluded that your submission is acceptable with the following label revision provisions:

1. Revise the marketing claims by deleting the statement "Also kills them on contact." This claim is misleading unless you can provide or cite specific efficacy data related to contact knockdown of flies.
2. Revise the **STORAGE AND DISPOSAL** statement as follows:

"STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Storage: Store [tightly] in original container in a cool, dry place. Protect from freezing. Store pesticides away from food, pet food, seed, fertilizers, and veterinary supplies.

Disposal: Do not reuse or refill this container. If Empty: Place in trash or offer for recycling if available. If Partly Filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain."

The Agency is in the process of developing and improving the current Efficacy Assessment Guidelines. The Agency intends to defer the determination of any related efficacy data requirements supporting the claims that may appear on this label until these Efficacy Assessment Guidelines are complete. When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for

personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised guidelines.


NOTE: This product is not being re-registered under FIFRA Sec. 4(g) at this time.

Farnam Companies, Inc. should note that a notice of availability of EPA's reregistration eligibility decision (RED) document for products containing pyrethrins was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42387-42389). EPA's RED for products containing piperonyl butoxide was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42385-42386). As a result, additional data and/or labeling changes may be required for products containing pyrethrins and/or piperonyl butoxide.
