The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the pyrethrins, piperonyl butoxide (PBO) REDs, and has concluded that your submission is acceptable.

NOTE: This product is **not** being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on <u>non-refillable</u> containers. The code may appear either on the label or durably marked on the container itself, and can be added by non-notification per PRN 98-10.

Please note that the record for this product currently contains the Confidential Statements of Formulation (CSFs) listed below. Any previously dated CSFs are superseded.

- 1 Basic CSF, dated 02/11/11

The only CSF contained within the application package is marked "Alternate 1" and is dated 9/10/09. Since the product chemistry review only makes mention of a single Basic CSF dated 9/10/09, it is assumed that this "Alternate 1" CSF was marked incorrectly, and it has now been updated as the "Basic" CSF for the product.

A copy of your label stamped "Accepted" is enclosed along with copies of the acute toxicity and product chemistry reviews completed for the subject product. Products shipped after 12 months from the date of this amendment or the next printing of the label whichever occurs first, must bear the new revised

label. Your release for shipment of the product bearing the amended label constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e).

This pesticide is toxic to aquatic organisms, including fish and invertebrates. Mix Repel-XP Emulsifiable Fly Spray with water at proper dilution. First put the required amount into sprayer or mixing container. Then add water according to directions and mix thoroughly before using.

IMPORTANT: Mix fresh solution before each use. Apply with pressure sprayer or sponge it on horses. Make sure animal's coat is thoroughly wet. Use approximately 8 oz. for each animal depending on size of horse or pony. Avoid getting solution into the animal's eyes.

HORSES: To protect horses from horn flies, house flies, gnats and mosquitoes apply at a 1 to 7 dilution. Each pint of concentrate makes a gallon of finished spray. Repeat application every 3 or 4 days or as often as needed. Where horse flies, deer flies (tabanids) stable flies, ticks or Deer Ticks, that may transmit Lyme Disease, are a problem, apply a 1 to 4 dilution and repeat as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store only in original container, in a dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.

PESTICIDE DISPOSAL AND CONTAINER HANDLING: Nonrefillable container. Do not reuse or refill this container. If Empty: Place in trash or offer for recycling if available.
