STORAGE & DISPOSAL

IN LOADING BARN, MILKING PARLORS AND MILK ROOMS: For fast control of Flies, Mosquitoes, Gnats, Wasps and Small Flying Moths, close all doors and windows and spray at the rate of 1 to 2 seconds per 1000 cubic feet. Direct fogger upward and spray in all directions. Keep room closed for 10 to 15 minutes after spraying. Do not remain in treated areas. Ventilate after treatment is completed. Cover utensils and milk to prevent contamination from spray and dead or falling insects.
