## GENERAL

New Formula Vita-Plus with Equitrol is a complete nutritional supplement with the additional benefit of Equitrol Feed-Thru Fly Control. Fed as directed, Vita-Plus with Equitrol will prevent the development of stable flies and house flies in manure, while providing a healthy balance of vitamins, chelated trace minerals, amino acids, organic selenium, balanced electrolytes and polyunsaturates. New Formula Vita-Plus with Equitrol also contains micronutrients from sea sources and natural food products including aloe vera juice, bone meal, wheat germ oil, kelp and brewer's yeast.

## DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

DO NOT USE ON HORSES INTENDED FOR SLAUGHTER.

Feed the recommended dosage to each horse separately to make certain he receives his full portion. This product should be fed top-dressed or mixed with the horse's total ration to provide 70 lbs. of ration per 100 lbs. of body weight. For an occasional finicky eater who does not accept new feeds readily, start by hand feeding this supplement a little at a time.

Begin feeding Vita-Plus with Equitrol early in the Spring before flies appear and continue feeding throughout the Summer and into the Fall until cold weather restricts fly activity.

Vita-Plus with Equitrol prevents the development of house flies and stable flies in the manure of treated horses but is not effective against existing adult flies. In some cases, supplemental fly control measures may be needed in and around paddocks and buildings to control adult house flies and stable flies which can breed not only in manure but in other bedding vegetable matter or silage on the premises.

In order to achieve optimum fly control Vita-Plus with Equitrol should be used in conjunction with other good management and sanitation practices.

DAILY DOSAGE

- 300 - 500 lb. Horse: Feed  $\frac{4}{5}$  oz. (One Vita-Plus with Equitrol measuring cup filled to the blue line) per horse per day.
- 500 - 700 lb. Horse: Feed  $1 - \frac{1}{5}$  oz. (One Vita-Plus with Equitrol measuring cup filled to the red line) per horse per day.
- 700 - 900 lb. Horse: Feed  $1 - \frac{3}{5}$  oz. (One Vita-Plus with Equitrol measuring cup filled to the green line) per horse per day.
- 900 - 1100 lb. Horse: Feed 2 oz. (One Vita-Plus with Equitrol measuring cup filled to the black line) per horse per day.

For larger horses over 1,100 lb.<sup>s</sup> of body weight feed  $\frac{1}{2}$  oz. for each 250 lb. of body weight. (Vita-Plus with Equitrol measuring cup is marked in orange at the  $\frac{1}{2}$  oz. level).
