Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

**Application Directions for Dogs:** Hold container 8 to 10 inches from dog and lightly spray on back, neck, face, back of neck, base of tail, and inside and outside ears. Do not get in eyes, nose or mouth. Avoid any contact with areas. If itching occurs, discontinue dog during air application, and cotton socks and rub product on ear surfaces. Repeat every day. **Application Directions for Surfaces:** Hold container 8 to 10 inches from non-feed non-feed surfaces such as pet bedding where insects rest. Do not spray this product when there is food present or when there are pets present. Remove any pets from the area before spraying. Repeat application when needed.
