ENVIRONMENTAL HAZARDS

This product is extremely toxic to fish. Do not apply directly to water. Do not contaminate water when disposing of equipment washwaters.

PHYSICAL OR CHEMICAL HAZARDS

EXTREMELY FLAMMABLE. Do not use or store near fire, sparks, or heated surfaces. Turn off pilot lights in gas appliances and unplug or turn off electrical equipment in the use area. Use Restrictions: Use only on dogs and non-food/non-feed surfaces to repel flies, gnats and mosquitoes. DO NOT USE ON PUPPIES LESS THAN 12 WEEKS OLD OR ON CATS.

Consult a veterinarian before using this product on debilitated, aged pregnant, nursing, or medicated animals. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

Application Directions for Dogs: Hold container 8 to 10 inches from dog and lightly spray on back, underside, legs, back of neck, base of tail, and inside and outside ears. Do not get in eyes, nose or mouth. Avoid any contact with sores. If hissing noise disturbs dog during ear application, mist cotton swab and rub product on ear surfaces. Repeat every day.

Application Directions for Surfaces: Hold container 8 to 10 inches from non-food/non-feed surfaces such as pet bedding where insects rest. Do not spray this product when there is food present or when there are pets present. Remove any pets from the area before spraying. Repeat application when needed.

STORAGE AND DISPOSAL

STORAGE: Store only in a cool, dry place away from heat and sunlight and inaccessible to children and pets.

DISPOSAL: If empty: Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.
