The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable subject to the comments listed below.

1. As noted in our letter of July 8, 1986, under directions for "OUTDOOR USE," replace:

Bad habits will be broken faster if Menoke' is used in conjunction with verbal scolding for misbehavior.

with:

This product is not likely to break the established urination patterns of dogs, unless it is used as a training aid (with verbal scolding for misbehavior).

2. Revise ingestion statement in the Statement of Practical Treatment to read "IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching the back of the throat with fingers."
3. Add to the Physical or Chemical Hazards statement "Do not use in the vicinity of pilot lights."

Submit five (5) copies of your final printed labeling before you release the product for shipment. Refer to the A-79 enclosure for a further description of final printed labeling.



IF SWALLOWED: Do not induce vomiting. Contact a physician or poison control center immediately.

IF INHALED: Remove person affected to fresh air.

IF IN EYES: Rinse thoroughly with plenty of water.

IF ON SKIN: Wash with soap and water.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Menoke Indoor-Outdoor Dog & Cat Repellent is a versatile repellent for puppies, dogs, kittens and cats. Use indoors or out to keep dogs and cats away from forbidden areas. An aid in training dogs and cats to stay off of furniture and rugs or out of forbidden rooms. Keeps your pet or stray pets away from garbage cans, flower beds, patios, lawn furniture and trees.

INDOOR USE: To break your pet of undesirable habits such as sleeping on furniture and rugs or to keep him out of forbidden areas. Spray the object lightly with Menoke until slightly moistened. Before spraying large areas of rugs, fabrics or plastics, test the effect of this product by treating a small, inconspicuous area. This product may stain or soften some fabrics or plastics. To avoid possible damage, spray a piece of cloth lightly and place it on the object or area to be protected. Repeat daily, or as necessary, until undesirable habit is broken.

For best results, Menoke should be used together with consistent training. Scold your pet firmly every time he disobeys, and always praise him for good behavior.

OUTDOOR USE: To prevent your pet or stray animals from disturbing flower beds, areas of lawn, trees, shrubbery, fences and patio furniture. Spray area to be protected lightly every day or every other day with Menoke. Reapply as often as necessary until undesirable habits are changed. Do not apply directly to foliage of shrubs or to ornamental, soft-bodied plants. Spray surrounding soil, or apply Menoke to a piece of cloth and affix near area.

Stray animals are frequently attracted to areas where pets have soiled with feces or urine. To discourage repeat visits, remove any dropping, clean area, and mask any remaining odor with Menoke. Bad habits will be broken faster if Menoke is used in conjunction with verbal scolding for misbehavior.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place inaccessible to children and pets and away from heat or open flame.

DISPOSAL: Do not reuse empty container. Rinse thoroughly. Securely wrap in newspaper and discard in trash.
