#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

No-Gnaw discourages dogs from chewing, licking or gnawing household articles. Treat only the object the dog is chewing; do not spray any other areas. Not for use as a preventative measure on objects not being chewed. Hold No-Gnaw approximately 6 inches away from chewed object and pump sprayer about 5 times or until object is covered. Repeat daily until habit is broken. On easily stained surfaces, test a small spot before applying full treatment. Do not allow spray to contact plastic surfaces. Avoid contamination of food.

For best results, use No-Gnaw in conjunction with firm, consistent training to permanently break chewing havits. Provide dog with his own chew toys, and give praise whenever he uses them. When dog chews forbidden objects, scold him and substitute his chew toy for the object. Treating forbidden objects with No-Gnaw will make dog's own chew toys much more attractive.

#### STORAGE & DISPOSAL

STORAGE: Store in a cool, dry place inaccessible to children and pets and away from heat or sunlight.

DISPOSAL: Do not reuse container. Rinse thoroughly before discarding in trash.
