1. Delete the "Makes it gentle on horse's skin" on the front label. Claims as to the safety of the pesticide or its ingredients in any form is unacceptable. We regret this was overlooked in our previous reviews.

Submit five copies of your final printed labeling before you release the product for shipment. A stamped copy of the labeling is enclosed for your records.

The basic Confidential Statement of Formula (CSF) dated May 1, 1990 indicating the corrected EPA Reg. No. for the source active ingredients is acceptable and a copy has been inserted in your file for the subject product. The alternate formulation dated July 11, 1990 with the removal of R-11 is acceptable and has been inserted into the file.

newspaper and discard in trash.

CONTAINER DISPOSAL: Do not reuse empty can. Wrap can and put in trash.


