Dear Ms. Sisson:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the following comments:

- Under "Precautionary Statements", revise the statement "*Wash thoroughly with soap and water after handling*" to read "*Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, using the toilet, etc.*".
- Under "Directions for Use", revise the statement "*For animal use only*" to read "*For use on horses and ponies only*". We requested this revision in our letter (dated March 4, 2004) to you.

Please make the changes to the product's labeling as indicated above, and submit two copies of the revised final printed label before you release the products for shipment and sale. A stamped copy of the accepted label is enclosed for your records.

ENVIRONMENTAL HAZARDS

This product is toxic to fish. Do not apply directly to water. Do not contaminate water when disposing of equipment washwaters.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not use on horses or foals intended for slaughter.

To protect horses from House Flies, Face Flies, Horse Flies, Stable Flies, Black Flies, Horse Flies, Deer Flies, Lice and Ticks and from biting gnats such as Punkies and No-see-ums: thoroughly brush the horse's coat prior to application to remove loose dirt and debris. For best results shampoo and rinse; wait until coat is completely dry and apply CRASH!WIPE-ON INSECTICIDE/REPELLENT.

DIRECTIONS FOR APPLICATION AS LOTION: Using protective gloves or mitt, apply a light film of two to four fluid ounces (60-120 ml) over horse's entire body, or spot treat areas of the horse where flies gather. May be applied around superficial wounds and abrasions. Avoid direct application to eyes, nose and mouth.

OPTIONAL DIRECTIONS FOR APPLICATION AS ROLL-ON: Remove cap from bottle. May be applied around superficial wounds and abrasions or spot treat areas of the horse where flies gather. May also be applied around animal's nose, eyes, ears and mouth. Avoid direct application to eyes, nose and mouth. Replace cap after use.

Repeat application as necessary but no more often than once every 5 to 7 days. Wash hands with soap and water after use.

STORAGE AND DISPOSAL

STORAGE: Do not contaminate water, food or feed by storage or disposal. Store in a cool, dry place inaccessible to children and pets. **DISPOSAL: If empty:** Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or call 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
