c. Under "Storage and Disposal" add:

Do not contaminate water, food, or feed by storage or disposal.

- d. The claim "long lasting" should be qualified with a time period.
- e. The claim "unique" may be used on new labeling for a period of 6 months following the Notice of Registration.
- f. Under Hazards to Humans and Domestic Animals the lecaution reads "avoid contact with skin." This comment is confusing since the product is applied directly to dogs and horses. Divide the comments into two sections (headings): Humans and Animals. Precautions currently on the label will suffice for Humans. Under Animals add:

Avoid contact with eyes or mucous membranes. Do not use on dogs, nursing puppies, puppies or foals under 6 weeks of age. Do not use this or any other pesticide on sick, old, or debilitated pets. Do not use on horses intended for food.

- h. Under Directions for Use for wasps and hornets add: "Application should be made in the late evening when insects are at rest."





To kill and repel House Flies, Stable Flies, Horn Flies, Face Flies, Horse Flies, Deer Flies, Mosquitoes, Ticks and Gnats on horses and ponies dilute at the following rate.*

<u>SPRAY</u>: First brush horse's coat to remove dirt and dust. Apply spray to animal paying special attention to legs. <u>shoulder</u> and neck. For head and eye area, dampen an applicator mitt, cloth or toweling (Turkish), spray and wipe over face. Be especially careful not to get in horse's eyes. Do not soak hair or skin. Repeat as necessary.

<u>WIPE-ON</u>: For body wipe-on, first brush horse's coat to remove excess dirt and dust. Dampen Turkish toweling (not a substitute material) and rub with growth of hair, paying special attention to legs, shoulders and face. For maximum protection, apply 2 - 4 ounces per animal. To kill attached ticks, daub directly onto ticks with a saturated cloth: tick will die in 24 hours. For best results, apply after shampooing.

Avoid using excessive amounts of wipe-on or spray on your horse. Do not soak the skin and avoid contact with horse's eyes and nostrils. Not for use on horses intended for food.

DOGS - DIP DIRECTIONS

To kill Fleas, Ticks and Lice on dogs, mix 2 Tablespoons (1oz.) of concentrate with 1.5 gallons of water. Dip, sponge or swab dog with this dilution until thoroughly wat. Allow dog to dry in a warm place without rinsing or toweling.

BACK PANEL

To protect dogs from pest reinfestation, apply at intervals of two or three weeks. Repeat application as required, but no more often than once every 2 weeks. **Do not use on old, sick or debilitated dogs.**

SPRAY: To kill Fleas, Ticks and Lice on dogs and to obtain protection against reinfestation apply product as follows:

Apply spray paying special attention to legs, shoulders and neck. Direct spray against the natural lay of the hair. On long-haired pets, rub your hand against the lay of the hair, spraying the ruffled hair behind the hand. Make sure spray thoroughly wets ticks. For head and eye area use wipe-on directions. Do not soak hair or skin. Repeat every two to three weeks or as needed. For best results, the kennels and/or animal quarters and bedding should be treated.

WIPE-ON: Dampen an applicator mitt, cloth or toweling (Turkish) with diluted concentrate. Rub over hair with special attention to the legs, sinculders, neck and facial areas. Be especially careful not to get in eyes.

Do not use on cats. Do not use on dogs nursing young, or puppies under 4 weeks of age.

PET PREMISES: To control Fleas, Ticks and Lice in kennels, pet bedding or

resting quarters, thoroughly spray infested areas, nearby cracks and crevices. Fresh bedding should be placed in animals quarters following treatment. Repeat treatment as needed.

For use in and around horse premises for control of House Flies, Stable Flies, Little House Flies (Fannia spp.), Mosquiloes, Ticks Gnats, Wasps and Hornets, dilute at the following rate:*

Apply finished spray to surfaces where Flies, Mosquitoes and Gnats rest at the rate of 1 gallon per 750 - 1000 square feet, or to the point of run off. Timing and frequency of applications should be based upon flies reaching nuisance levels but no more often than once every two weeks. Do not contaminate animals feed or water by spray.

For control of wasps and hornets, apply or ectly to nest location as required.

*For ease in diluting, shake or agitate the concentrate and add it to 1/2 water in the dip tank, mix, add the remaining water and agitate again. While applying a spray dilution, shake occasionally.

For Dog Dip, Spray-On, Wipe-On, Pet Premise Spray, and Horse Spray-On and Wipe-On:
