The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped "Notification" and will be placed in our records.

The alternate brand names "Farnam Wipe II Brand" and "Wipe II Brand" have been added to the product record.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not use in outdoor residential misting systems. Not for use on horses or foals intended for slaughter. Only spray in well-ventilated area. Do not allow the product to contact animal's eyes, nose, mouth, or sores during application. Do not use on foals under 12 weeks old. Do not apply more than once per day.

Applicators and other handlers must wear long-sleeved shirt and long pants, socks, shoes, and chemical-resistant gloves made of barrier laminate, nitrile rubber, neoprene rubber, or viton.

Farnam Wipe Spray II (Bronco Gold Equine Fly Spray)(Farnam Wipe II Brand)(Wipe II Brand) has been especially developed for use on horses. It provides a protective hair coating against flies while imparting a high sheen to the hair when brushed out. One to two ounces per head per day gives adequate protection. Apply by either soft cloth or fine mist spray.

USE TO WIPE ON: First, brush animal to remove excess dirt and dust. Moisten (but do not wet to the point of dripping) a soft cloth and rub over the hair. It is best to apply by rubbing against the hair growth. Give special attention to the legs, shoulders, shanks, neck and facial areas where flies most often are seen

Only a light application is required. Avoid using an excessive amount on your horses. Do not wet skin.

After application, brush out thoroughly to bring out bright sheen on the coat.

Repeat daily or as required.

USE AS A SPRAY: Farnam Wipe Spray II (Bronco Gold Equine Fly Spray)(Farnam Wipe II Brand)(Wipe II Brand) may be applied as a fine mist spray to stable area and over and around stabled horses for fast paralysis and kill of flies. Do not wet horse's skin or exceed two ounces per application.

USER SAFETY RECOMMENDATIONS

Users should:	 Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet Remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.
