Hazards to Humans: Harmful if swallowed or absorbed through the skin. Avoid contact with skin, eyes or clothing. Causes moderate eye irritation. Wash thoroughly with soap and water after handling.

Hazards to Domestic Animals: For external use on adult dogs only. Do not use on dogs less than 6 months of age. Do not use on sick, aged, medicated; pregnant; or nursing dogs without consulting a veterinarian. Consult a veterinarian before using on dogs with known organ dysfunction. STATEMENT OF PRACTICAL TREATMENT

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Read entire label before using. DO NOT USE ON CATS or animals other than dogs. Do not get this product in your dog's eyes or mouth. Repeat applications may be made if necessary, but do not apply more often than once every 3 weeks. Do not use this product in or on electrical equipment due to the possibility of shock hazard.

For Dogs Weighing Less Than 33 pounds: Apply one tube (1.5 TAL) of FARNAM PURGE INSECTICIDE solution to the dog's back between the shoulder blades.

For Dogs Weighing More Than 33 pounds: Apply one tube (1.5 mL) of FARNAM PURGE INSECTICIDE to the dog's back between the shoulder blades and apply a second tube (1.5 mL) to the dog's back directly in front of the base of the tail.

HOW TO APPLY:

FOR FOLDING CARD OR TABBED CARD UNIT-DOSE PACKAGING: Remove product tab by tearing along perforation. Holding tab with tube end pointed up and away from face and body, cut along dotted line. Invert tab over dog and use narrow end of tab to part dog's hair. Squeeze the tube firmly to apply all of the solution to the dog's skin. Wrap tab and put in trash.

FOR FLAT CARD (doubled) UNIT-DOSE PACKAGING: Separate cards along the perforated line. Holding separated card by its wide end with narrow end pointed up and away from face and body, cut along dotted line. Invert card over dog and use narrow end to part dog's hair. Squeeze tube firmly to apply all of the solution to the dog's skin. Wrap card and put in trash.

- ** FOR DROPPER BOTTLE MULTI-DOSE PACKAGING: Insert dropper tube into insecticide solution, squeeze bulb and then release to fill tube barrel to 1.5 mL line. Position dropper tube end in dog's hair next to skin and squeeze bulb to apply all of the solution to the dog's skin.
- ** FOR MULTI-DOSE PACKAGING: Withdraw 1.5 mL of solution at a time. Apply entire given dose directly to the skin at the indicated locations.
