Subject: Amendment- additional market claims Farnam Purge Pesticide EPA Registration Number 270-279 Your submission dated August 21, 2009

The application referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following comments:

1. Delete ALL applicator claims. These claims are vague.

2. Change "Provides Tick Protection" to "Provides Tick Protection On Listed Pests".

3. Change "Repels [Ticks] [Mosquitoes] [On Horses]" to "Aids In the Control of Mosquitoes On Horses".

4. Delete "Lasting Protection Against Ticks [On Horses], "Continuous [Fly] And [Tick] Protection [For Horses]" and "Provides [Continuous][Lasting] Protection". No efficacy data was submitted or cited to substantiate these claims. These claims are vague.

5. Delete "Pleasant Scent [Smelling]. This is a subjective claim.

6. You cannot delete "Contains Petroleum Distillate". A new Confidential Statement of Formula was not submitted with this application changing the last acceptable basic Confidential Statement of Formula.

7. Under First Aid after "Have the product container or label with you when calling a poison control center or doctor, or going for treatment." add " a box "NOTE TO PHYSCIAN: Contains petroleum distillate. Vomiting may cause aspiration pneumonia.". A new Confidential Statement of Formula was not submitted with this application changing the last acceptable basic Confidential Statement of Formula.

A copy of a stamped label is enclosed for your records.

The enclosed note from George LaRocca dated September 15, 2008 explains your options concerning oil of citronella. Please respond to the Agency explaining how you will resolve the oil of citronella issue.
