For Dogs Weighing Less than 33 Pounds: [1.5 ml applicator tube] Apply one tube (1.5 ml) of product solution as a spot between the shoulder blades or as a stripe to the dog's back.

For Dogs Weighing More than 33 Pounds: [1.5 ml applicator tube] Apply one tube (1.5 ml) of product solution as a spot between the to the dog's shoulder blades or as a stripe to the dog's back <u>and</u> apply a second tube (1.5 ml) as a spot directly in front of the base of the tail or as a stripe to the dog's back.

Rev. 1/09 Page 4 of 7 Rev 8/09 For Dogs Weighing More Than 33 Pounds: [3.0 ml applicator tube] Apply approximately half of the tube (1.5 ml) of product solution as a spot or stripe to the dog's back between the shoulder blades <u>and</u> apply the rest of the tube's contents (1.5 ml) as a spot or stripe to the dog's back directly in front of the base of the tail. Or, apply the entire tube (3.0 ml) as a continuous stripe on the dog's back starting between the shoulder blades and ending directly in front of the base of the tail.

### HOW TO APPLY:

FOR FOLDING CARD OR TABBED CARD UNIT-DOSE PACKAGING: Remove product tab by tearing along perforation. Holding tab with tube end pointed up and away from face and body, cut along dotted line. Invert tab over dog and use narrow end of card to part dog's hair. Squeeze tube firmly to apply all of the solution to the dog's skin. Wrap tab and put in trash.

FOR FLAT CARD (doubled) UNIT-DOSE PACKAGING: Separate cards along the perforated line. Holding separated card by its wide end with narrow end pointed up and away from face and body, cut along dotted line. Invert card over dog and use narrow end of the card to part dog's hair. Squeeze tube firmly to apply all of the solution to the dog's skin. Wrap card and put in trash.

FOR FLAT CARD UNIT DOSE PACKAGING: [for push pin type applicator] Remove one product tube from card. With cap end pointed up and away from face and body, depress cap to pierce tube end. Carefully remove cap, invert tube over dog, and with tube in close to dog's skin, squeeze tube to apply product. Wrap empty tube and put in trash.

BLISTER PACKED SARAN TUBES: Remove product tube from package. Holding tube with notched end pointing up and away form face and body, cut narrow end at notches. Invert tube over dog and use open end to part dog's hair. Squeeze tube firmly to apply all of the solution to the dog's skin. Wrap tub and put in trash.

PULL AND TWIST APPLICATOR TUBE: Remove applicator tube from package. Hold applicator tube in an upright position. Pull cap off tube. Turn the cap around and place other end of cap back on tube. Twist cap to break seal, then remove cap from tube. The dog should be standing for easy application. Part the hair, place the tip of the tube on the skin and gently squeeze to expel the solution on the skin. Discard empty tube as described in Storage and Disposal.

BLISTER CARD WITH TRI-LAYER TUBES: Remove product tube(s) from package. Fold along perforation between tubes and tear off one tube. (Return unused tubes to package.) Holding tube with notched end pointing up and away from fact and body, snap off narrow end at notches. Invert tube over dog and use open end to part dog's hair. Squeeze tube firmly to apply all of the solution to the dog's skin. Wrap tube and put in trash.
