Purpose The purpose of this submission, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is to revise the first aid text of your label in accordance with PR Notice 2001-1 and 2001-6.

Label review The labeling submitted with the above letter, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided you submit one (1) copy of final printed labeling to us, with the following changes, before you ship your product.

1. We suggest revising your "FIRST AID" text as indicated in Enclosure 1.
2. Revise your "STORAGE AND DISPOSAL" text as follows:

STORAGE AND DISPOSAL

Storage: Store only in original container in a cool, dry place inaccessible to children and pets.

Disposal: If empty: Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or call 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.


A copy of the stamped label is enclosed for your records.

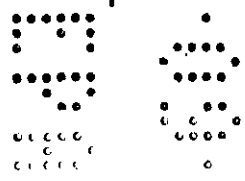



This product repels dogs and cats for up to 24 hours when applied daily. Keeps pets away from furniture, carpet, trees, shrubs, garbage cans/bags, and other "forbidden areas".

OUTDOOR USE:

Keeps pets away from trees, shrubs, garbage cans/bags, and other "forbidden areas". Reduces frequency of defecation and urination by dogs on lawns and flower gardens. Reduces frequency of digging by cats in flower gardens.
