## PRECAUTIONARY STATEMENTS

## HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed. Remove or cover exposed foods before spraying. Do not apply to dairy animals.

STATEMENT OF PRACTICAL TREATMENT: If swallowed, do not induce vomiting unless directed by physician. Petroleum distillate may cause aspiration pneumonia. Contact physician immediately. If in eyes, flush eyes with plenty of water. Contact physician if irritation persists. If inhaled, remove victim to fresh air. Apply artificial respiration of indicated. If on skin, remove contaminated clothing and wash affected areas with plenty of soap and water.

ENVIRONMENTAL HAZARDS: This product is toxic to fish. Do not apply directly to water. Do not apply where runoff is likely to occur. Do not contaminate water by cleaning of equipment or disposal of wastes.

PHYSICAL OR CHEMICAL HAZARDS: Dó not use or store near heat or open flame.

For use on horses to kill and repel stable flies, horn flies, house flies; face flies, horse flies, deer flies, mosquitoes and gnats. Also can be used as a grooming aid and coat conditioner.

## DIRECTIONS FOR USE

-It is a violation of Federal law to use this product in a manner inconsistent with its labeling.
Flysect Citronella Spray has been especially developed for use on horses. It provides a coating against flies while imparting a high sheen to the hair when brushed out. l-2 oz per head per day gives adequate protection. apply either by soft cloth or fine mist spray.

USE TO WIPE ON: First brush the animal to remove excess dirt and dust. Moisten (but do not wet to point of dripping) soft cloth and rub over the hair. It is best to apply by rubbing against the hair growth. Give special attention to the legs, shoulders, shanks, neck and facial areas where flies most often are seen. Only light application is required. Avoid using excessive amount on your horses. Do not wet skin. After application, brush out thoroughly to bring out bright sheen on the coat. .Repeat daily or as required.

USE AS A SPRAY: May be applied as fine mist spray to stable area and over and around stabled horses for fast paralysis and kill of flies. Do not wet horse's skin or exceed 2 oz. per application.

STORAGE \& DISPOSAL: Do not contaminate water, food or feed by storage or disposal.
Pesticide Storage and Spill Procedures: Store upright at room temperature. Avoid exposure to extreme temperature. In case of spill or leakage, soak up with an absorbent material such as sand, sawdust, earth, fuller's earth, etc. Dispose of with chemical waste.

Pesticide Disposal: Pesticide, spray mixture or rinse water that cannot be used according to label instructions must be disposed of at or by an approved waste disposal facility.

Container Disposal: Do not reuse container. Wrap container in several layers of newspaper and discard in trash.
