Dear Mr. Johnson:

This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations CFR 152.46, and no other changes will be made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.

The purpose of this notification is to allow for the use of blister card with tri-layer tubes as an alternate package presentation.

The label is being revised to add the following statement under the "HOW TO APPLY" section of the label due to the addition of a new package presentation:

BLISTER CARD WITH TRI-LAYER TUBES:

"Remove product tube(s) from package. Fold along perforation between tubes and tear off one tube. {Return unused tubes to package} Holding tube with notched end pointing up and away from face and body, snap off narrow end at notches. Invert tube over dog and use open end to part dog's hair. Squeeze tube firmly to apply all of the solution to the dog's skin. Wrap tube and put in trash."


