The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Pyriproxyfen Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must submit one copy of the final printed labeling before you release the product for

shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Read entire label completely before using. Do not get this product in your pet's eyes or mouth. Repeat applications may be made if necessary, but do not apply more often than once every 3 weeks. Do not use this product in or on electrical equipment due to the possibility of shock hazard. Do not use on kittens or puppies under 12 weeks of age or on ferret kits under 16 weeks of age.

HOW TO APPLY:

Dosage: For cats, kittens, dogs, puppies, ferrets, and ferret kits weighing less than 33 lbs. apply one tube (dose)(1.5 ml). For dogs and puppies weighing more than 33 lbs. apply two tubes (doses)(total 3 ml).

[FOR FOLDING CARD OR TABBED CARD UNIT-DOSE PACKING:] [Remove product tab by tearing along perforation. Holding tab with tube end pointing up and away from face and body, cut along dotted line. While gently holding cat (dog, ferret, pet), use the narrow end of the tab to part cat's (dog's, ferret's, pet's) hair, and apply product as a narrow stripe down cat's (dog's, ferret's, pet's) back from back of head to base of tail. Squeeze tube firmly to apply all of the solution directly to cat's (dog's, ferret's, pet's) skin. Continue to gently restrain cat (dog, ferret, pet) for a few seconds until product absorbs into cat's (dog's, ferret's, pet's) coat. Wrap tab and put in trash.]

[FOR SARAN TUBES IN BLISTER CARD:] [Remove product tube from package. Holding tube with notched end pointing up and away from face and body, cut off narrow end at notches. Invert tube over pet and use open end to part cat's (dog's, ferret's, pet's) hair. Squeeze tube firmly to apply all of the solution to the cat's (dog's, ferret's, pet's) skin. Wrap tube and put in trash.]

[BLISTER CARD WITH TRI-LAYER TUBES:] [Remove product tube(s) from package. Fold along perforation between tubes and tear off one tube. [Return

unused tubes to package.] Holding tube with notched end pointing up and away from face and body, snap off narrow end at notches. Invert tube over dog and use open end to part dog's hair. Squeeze tube firmly to apply all of the solution to the dog's skin. Wrap tube and put in trash.]

[*FOR MULTI-DOSE PACKAGING:] [Withdraw 1.5 ml of solution at a time. While gently holding cat (dog, ferret, pet), apply entire given dose directly to the cat's (dog's, ferret's, pet's) skin as a narrow stripe down the cat's (dog's, ferret's, pet's) back from the back of the head to the base of the tail. Continue to gently restrain cat (dog, ferret, pet) for a few seconds until product absorbs into cat's (dog's, ferret's, pet's) coat.]

[*FOR DROPPER BOTTLE MULTI-DOSE PACKAGING:] [Insert dropper tube into insecticide solution, squeeze bulb and then release to fill tube barrel to 1.5 ml line. While gently holding cat (dog, ferret, pet), position dropper tube end in cat's (dog's, ferret's, pet's) hair next to skin and squeeze bulb to apply entire given dose directly to the cat's (dog's, ferret's, pet's) skin. Apply as a narrow stripe down cat's (dog's, ferret's, pet's) back from the back of the head to the base of the tail. Continue to gently restrain cat (dog, ferret, pet) for a few seconds until product absorbs into cat's (dog's, ferret's, pet's) coat.]

FARNAM F724 is an effective and easy to use product. FARNAM F724 prevents eggs from fleas on treated cats (dogs, ferrets, pets) from developing into biting adults for three months. As with all flea control products, FARNAM F724 should be used as a part of a program aimed at reducing flea populations in the cat's (dog's, ferret's, pet's) environment (bedding, carpet, yard). For existing flea infestations, a premise treatment including an adulticide and larvacide should be used prior to treating your pet with FARNAM F724.
