Sulfodene® Scratchex® Flea & Tick Killer for Dogs & Cats has been scientifically formulated to both kill fleas and to keep working up to 14 days on dogs to prevent reinfestation. For use on both dogs and cats. Spray infested areas around baseboards, wall cracks, sleeping quarters and localized areas of floors and floor coverings. Applications should be repeated as infestations warrant and as reinfestation occurs.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Shake the container well before using. Hold bottle upright during use. Spray the animal from a distance of 8-12 inches. Sprayer works best with forceful pumping action. Start spraying at the tail, moving the dispenser to make sure the entire animal's body is covered, including the legs and under the body. Using a protective mitt or glove, fluff the hair as you spray so the spray will penetrate to the skin. The spray should wet the ticks thoroughly. Do not, however, over-saturate the fur or skin of the animal. Use in pet's sleeping areas or on bedding, walls, furniture, floors, and carpeting to control infestation. Reapply every week as needed.

Harmful if swallowed. Avoid breathing vapors. Do not spray in eyes, face or on genitalia. Do not use on dogs or cats under 12 weeks of age.
